To issue a form I-20, which is the required documentation you will receive from Guilford College to apply for an F1 visa, Guilford College is required by the US government to collect proof of financial solvency. We collect that through your completion of this form and your submission of supporting documentation of the funds you have access to for your education. If the documentation you submit satisfies the requirements we will issue you a form I-20. It is our legal obligation to be sure that you and your family show funds to cover the entire cost of your education and we do so by collecting proof of funds for one academic year at the College which includes tuition, fees and living expenses ([undergraduate](#), [graduate](#), and [Continuing Education](#)). While we specifically collect information for one year please expect that our fees are likely to increase slightly each year and applicants should not expect additional scholarship funding from Guilford College.

This document must be complete, signed and uploaded via your Guilford College Leadership Status page. You must also submit a current bank account statement showing the funds articulated in this document. The bank statement should be translated into English, state the account holder's name and show funds available. The Bank Statement should also be on official letterhead and include the date.
